Application and dosage



Daily routine cleaning:
20 - 100 ml / 10 l water



Daily routine cleaning:
20 - 100 ml / 10 l water



Machine cleaning:
50 - 100 ml / 10 l water



Spray cleaning:
50 ml / 600 ml water
