WC cleaning: Neat



Daily routine cleaning: 20 - 100 ml / 10 l water



Daily routine cleaning: 20 - 100 ml / 10 l water



Single-disc machine: 200 - 1000 ml / 10 I water



Foam gun: 1:5 to 1:10 with water



Foam spray cleaning: 50 ml / 600 ml water
