Application and dosage



Wiping care:
150 ml / 10 l water



Cleaners:
1:1 with water



Requirements:
The floor covering must have been subject to a basic clean, rinsed with clean water and dried. The floor covering must be free from surfactants.

Coating:
Neat
Thinly apply 2-3 coats of the product; each coat must be allowed to dry thoroughly.

For absorbent floor coverings such as old linoleum coverings, pre-treatment with Corridor® Basic S 720 is recommended. Using the product with Corridor® Basic S 720 significantly improves the look, lifespan and adhesion of Corridor® Complete S 732 on these coverings.

Note

Protect against frost. Switch off heat sources (radiators, underfloor heating, etc.) before processing. Avoid direct sunlight. Always use cold water. Changes or variations in colour do not impact on product quality.
