## Wiping care based on water-soluble polymers

## **Application and dosage**



Daily routine cleaning: 20 - 50 ml / 10 l water

Initial treatment:

500 - 1000 ml / 10 I water

For wet wiping apply to the floor, leave to dry, and then polish up with a high-speed machine or a single-disc machine with a polishing pad installed.



Machine cleaning: 50 - 100 ml / 10 l water



Cleaners:

1:3 with water

Buff with a high-speed machine or a single-disk machine.



Intensive cleaning: 500 ml / 10 l water

Clean with a single-disk machine and a cleaning pad. Remove dirt solution with a vacuum cleaner and polish floor.



Spray cleaning: 300 ml / 10 l water

#### Note

Always use cold water.

When being used in the automat, the tanks should be regularly cleaned and rinsed
