Application and dosage



Daily routine cleaning: 100 ml / 10 l water



Machine cleaning: 100 ml / 10 l water

Intensive cleaning: 500 - 1000 ml / 10 I water



Removing heel marks: 1:2 to neat Apply, scrub, remove dissolved dirt and rinse with clean water.

Note

Always use cold water. Rinse afterwards with clean water. When using with machines, tanks should be regularly cleaned and washed. Changes or variations in colour of the product do not impact on the quality.
