### Application and dosage



Daily routine cleaning:  
50 - 100 ml / 10 l water



Daily routine cleaning:  
50 - 100 ml / 10 l water



Machine cleaning:  
50 - 200 ml / 10 l water  
Buz® Defoam G 478 can be used for heavy foaming.

Escalator cleaning:  
Brushing/suction: 1-2 l/10 l water  
Compression sprayer: 1:1 to 1:2 for prespraying  
Put cleaning solution into the machine and clean using brushing/suction procedure.  
Attention: maximum exposure time: 30 minutes



Spray cleaning:  
50 ml / 600 ml water

### Note

Always use cold water.  
When using with machines, tanks should be regularly cleaned and washed.  
Apply solutions when fresh and use within 24 hours at the latest. Changes or variations in colour do not impact on product quality.
